1. Program & Eligibility

3. Links, Cookies & Attribution

Sales are tracked by your unique affiliate link/ref ID. Last valid click generally applies. Tracking methods may change for accuracy/fraud prevention.

4. Commissions & Payouts

Rates: 50% of tradeline monthly dues (non-promo), 25% during promo, 10%–20% vendor marketplace referrals, plus additional services as listed on the Affiliate Program page. Paid twice monthly via ACH, subject to refund/chargeback periods and a \$50 minimum.

5. Refunds, Chargebacks & Cancellations

Refunds/chargebacks reverse the related commission. Negative balances may offset future earnings.

6. Traffic Quality & Prohibited Conduct

No spam, bots, incentivized clicks, cookie stuffing, brand bidding on "Strike Force Agency" or variants, or unauthorized couponing.
